2. The Office of the Information Commissioner (OIC) confirms the account information indicated overleaf as the account which will be used for the collection of the fees payable by data controllers as defined by the Act.
3. All fee payments must be made at the rates prescribed for each category of data controllers stated in the Schedule of the Regulations in **Jamaican Dollars (JA\$)** or its equivalent in any other currency.
4. Data controllers should pay keen attention to the banking information provided overleaf and ensure that **fee payments are made to the correct account**. The OIC accepts no responsibility or liability for any error made by any data controller, or their agents, employees or officers, in effecting fee payments to any other account than that account specified overleaf.
5. Where there are any changes the banking information provided overleaf, the OIC will issue an advisory by public notice and as a notification to data controllers through their accounts on the [My OIC Portal](#) on the website, www.oic.gov.jm.
